- You must order seats for each tour separately as orders may be processed by a different committee member for each tour. The cost includes GST, PST and all gratuities.
- Enclose the order form for each tour in which you wish to participate with your payment for that tour.
- All cheques are to be made payable to District 13 tours committee. No post dated cheques, please.
- For all tours, those who cancel out after the deadline will pay a charge for expenses that cannot be recovered.
- When tickets are involved, they will be distributed on the day of the event.
- (a) Acceptance of your cheque by the treasurer is confirmation of your reservation.  
(b) If your name is placed on a waiting list, you will be informed by telephone. If you are on the waiting list and are fortunate enough to get on the tour, you will be called again, if not your cheque will be shredded.
- (c) Record on your calendar the date of all tours in which you plan to participate. Do not plan on refunds.
- For most tours we plan to use Wills Motors Ltd. Which originates in Binbrook. Pre-boarding can be arranged by calling 692-4423.
- Please leave the front seat opposite the driver (door side) for the Tour Guide.
- At each stop, the sides will alternate when exiting.
- Note the number of the bus and the driver's name if more than one bus is used.
- Drop-off points for all returning buses are the same as pick-up locations.
- No smoking permitted on the bus.
- If fewer than 30 persons sign up for a tour, the tour may be cancelled.
- When two buses are used and you wish to sit with a friend, you should both board at the same location if possible.

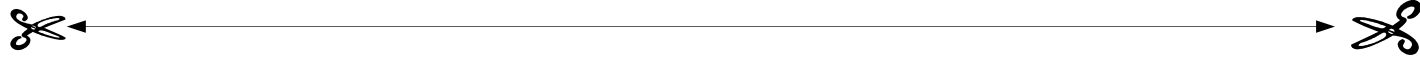
